

Objectives of the Charity

Yeadon Sailing Club (YSC) was established in 1928 and sails on Yeadon Tarn which is approximately 20 acres in size and has a maximum depth of about 6 feet. YSC has a long tradition of providing excellent racing, training and social sailing opportunities to all members of the community from the Yorkshire region. YSC provides individuals of all levels with an opportunity to push themselves and take on a new challenge.

The club maintains a clubhouse, dinghy park and a fleet of club boats for the purposes of providing sailing opportunities for its membership. Encouragement and facilities are made available to attract all those who want to experience sailing. Membership is open to all and visitors are welcome.

The objects of Yeadon Sailing Club are

(1) To promote community participation in healthy recreation by providing facilities to

participate in water-based amateur sport; and

(2) To advance education for the public benefit in the subject of water-based sports.

Public Benefit Statement

In setting our objectives and planning our activities, the Trustees and Committee have given serious consideration to the Charity Commission's guidance on public benefit.

Review of Activities

Key activities during the year included:

Training including Tuesday nights, Saturday training and Race Training. Push the Boat Out/Open Day Come & Try Racing programme including Wednesday, Saturday and Sunday Series as well as Trophy Races and Open Meetings Commodore's Weekend Bart's Bash Social activities including Tarn Yarns and Laying Up Supper

Financial Review

As at the 31st December 2018 we had £18,816 on deposit at the Skipton Building Society, £12,051 on deposit in the Skipton BS Building Fund and £9681 at Yorkshire Bank.

The accounts show a deficit for the year of \pounds 3,030, however this includes the expenditure from the Building Fund of \pounds 6250 on the access ramp and decking.

A few key points to note, the clubhouse donations of £3,931 include donations from individuals, social events and Easyfundraising. However, the donations for duck food totalled £3739, expenditure for duck food was £1753 providing a net income of £1986. Thank you to Mary Dawson for her ongoing commitment to organising the duck food.

Taking out the expenditure of the decking, and the income/expenditure from the duck food, the income figure is around £500 less than the expenditure figure. However, we have seen a drop off in the membership, partly due to no-one following people up during the renewal period.

Reserves policy

It is the clubs' policy to maintain a balance in the region of £15,000 which equates to approximately 9 months running costs.

Risk and Internal Control

The Club has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss. These include financial controls and comprehensive insurance policies are in place to ensure that insurable risks are covered.

Plans for future years

The phased refurbishment of the Clubhouse continues. The Club has installed a ramp providing access to the main room in the clubhouse and a decking area to enable members to view the sailing activities from outside. Further areas for development include the changing room and the kitchen area.

The Club is considering ways to continue to develop different types of sailing activities including a number of one day trophy events, social sailing at a variety of times as well as continuing with a range of training activities and the racing calendar.

Structure, governance and management

The charity is governed by the constitution and was recognised by the Charity Commission on 14th September 2016. The club is affiliated to the Royal Yachting Association and all activities organised by the club take place under the jurisdiction of the national body.

The Trustees of Yeadon Sailing Club, acting as a Board, carry the responsibility of complying with the requirements of the Constitution.

Other key documents include

Terms of Delegation - the trustees have delegated management responsibilities to the club's committee. Operating Rules - laid down by the Trustees and Committee, by authority of the Constitution, and can be altered from time to time at its discretion.

The trustees meet twice per year referring operational details to the committee which meets more regularly.

Declaration

The trustees declare that they approved the report and accounts for the period ended 31st December 2019 on 25th February 2020.

Independent Examiner's Report to the trustees of Yeadon Sailing Club

1. Accounting policies

Basis of accounting

The trustees have taken advantage of section 133 of the Charities Act 2011 and have prepared the accounts on a receipts and payments basis.

No changes have been made to the accounts for previous years.

Taxation

As a registered charity the organisation benefits from rates relief and is generally exempt from income tax and capital gains tax but not from VAT. Irrecoverable VAT is included in the cost of those items to which it relates.

Fund accounting

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

The Building Fund is money raised to be used for the improvement of the Clubhouse.

Appendix 1 – Officer's Reports

Rear Commodore's Report – Sarah Cooke

It is always a pleasure to reflect on another great sailing season here at Yeadon Sailing Club. This year, the leadership has been slightly different than usual, with jobs being spread out across the committee, but more volunteers are needed to ensure the smooth running of the Club in the future.

Firstly, we've all made the most of the new decking and it's been lovely to be able to watch the racing from outside.

We have celebrated:

- Start Sailing in May with the Open Day introducing new sailors to the water.
- Come and Tries every Tuesday evening
- Many new Junior members
- Training sessions on both a Tuesday evening and Sundays in the Autumn.
- Regular racing on Wednesdays, Saturdays and Sundays with some new faces racing (see it's not as scary as it seems!)
- A fun Commodores Day in July
- 20 boats on the water for Bart's Bash in September

We also have an emerging Laser Fleet with the club investing in more Lasers.

Together the team has shown how everyone has supported activities, stepped in to lead events and generally be available and willing to help with whatever is going on. Anyone wanting to join the team or help run anything please do make yourself known to the Committee.

Sailing Secretary's Report – Jon Wheble

Jon Wheble, with help from Tony Langley, has taken over the role of Sailing Secretary from Martin Ashby on an interim basis until the AGM – Thanks goes to all those who have helped with this handover, including Martin, Tony, David Statman and Patrick Gaunt.

Looking back over 2019, the normal racing continued successfully with the Wednesday evening, Saturday, Sunday and Frostbite series' all attracting new sailors as well as old hands. The Trophy races, as usual, were popular and closely contested. There were 30 sailors who raced on Saturdays (with 8 qualifying for the results), 40 on Sundays (10 qualifiers), 20 on Wednesdays (9 qualifiers) and 16 in the Frostbite (9 qualifiers).

This coming year the series and trophy races will be the same but, just to clarify, the trophy races will not qualify as part of a series (so that winning one trophy doesn't count towards winning another). Next year we are considering the option of changing the series so that they are shorter but cover all race days, so qualifying for each will take fewer races – keep an eye open for more details later in the year.

There were also a number of 'Day Trophies' aimed at encouraging newer and less competitive sailors to take part, and these will continue in a slightly modified form in the coming year as 'Family Day Trophy' races. As the name suggests these will be aimed at all ages and skill levels - we hope everyone will come and take part to make them the real social events they are expected to be. Maybe we'll have a BBQ set up if the weather is good as well?

As usual we hosted a number of single fleet Open Meetings, welcoming sailors from all over the country for the Heron, National 12 and Streaker/Solo Opens – Thanks to the Classes and their captains for looking after these. In addition, we hosted the YHYSA Junior Sailing Regatta in May which is part of the Yorkshire wide Junior series and welcomed junior sailors from a number of different clubs to the joys of sailing at Yeadon.

The Topper and Laser Opens have not been included in their respective regional Class series now, so were not run – The Laser Open day was instead used for Laser training and we possibly had more Lasers on the water than if the Open had been run! It's great to see many new sailors taking up the sport in these popular boats - the club now has a number of them available as well as quite a few newer members buying these as a first boat.

This coming year the Topper and Laser Opens have been replaced by 'Fleet Pursuit Day' races – Everyone is welcome to take part in these but the Topper/Laser fleets respectively will have a prize giving. As they are pursuit races, all racers in each class will set off together, with the finish line and number of laps being the same for everyone. If things go perfectly then everyone will cross the line at the same time!

We are continuing to use Dutyman for scheduling OOD and AOOD duties – the price has gone up significantly this year but there isn't anything else available that does the same job so we'll stay with it for now, even if it is a little 'quirky'. Last year there were quite a few occasions with no volunteer or with members not turning up for scheduled duties, which is always disappointing for those wanting to sail. As always the club is entirely dependent on volunteers for everything, but this is the only area where volunteering is *expected* from all members – All we ask is, for non-racers, that you give up just two weekend afternoons in the year to help out. It's not complicated and you will be with someone who knows what they're doing, mostly acting as an extra pair of hands. If you haven't raced before then helping out as an AOOD is actually a great way of finding out what happens in a race *and* of meeting people you probably haven't seen before. We are expecting to run some AOOD training fairly early in the season if you want to get a bit more of an idea on how it works before your duty days.

Some other options are being considered for racing without an OOD but this is a last resort as the OOD is the safety support for anyone getting into trouble.

Other ideas for further developing the more informal sailing opportunities are being considered as a result of attending the NE Region RYA Regional Conference.

Bosun's Report – Paul Bradley

Most important concern this year has been continued problem with roof. The problem lies with the seal at the base of the large roof window. Before we had the roof completely replaced last year this was a major leakage area, with the new work it is improved but still leaks. This was not immediately apparent for some months after the new roof was finished as it is a small drip concealed behind the ceiling.

Some of the ceiling has been removed now and we can actually see the water seeping in.

The contractors have returned to work on it several times and each time there have been improvements but at time of writing it still has a leak.

Recent storms have helped highlight the exact point of entry recently and contractors are coming back hopefully with a final fix.

New decking seems to have been received well and we have been given go ahead to lower the foliage in front so races can be seen more clearly. This will involve a bit of work to keep a secure front and will also involve some tidying up we need to do to the gate access to the front of the club.

Fishermen have installed a small storage area in corner of boat park accessed from outside and the two clubs seem to have good working relationships at moment.

Working parties have continued to do splendid work numerous small and large improvements made including some nice landscaping.

Priorities apart from roof for next year are:

Considering a kitchen refit for both practical and aesthetic reasons.

Regular strimming of boat park either by ourselves or contracted out.

Forming a relationship with the cricket club which we think could be of mutual benefit (some initial contacts have been made).

Membership Report

We have continued to use Webcollect to manage the membership records and renewals and a small number of people are administrators which spreads the workload. Bryan Haddington was Membership Secretary for a few months at the start of the season and worked with Andrew Cowling to send out the renewals. However, he has since decided to move onto sailing bigger boats. This left the Club without a Membership Secretary to follow up people who had not renewed which has led to a continued drop in the membership numbers. However, there is a pleasing growth in the number of junior members.

We also had a good group moving up to intermediate training - thank you to Luke for his coaching of this group, and for teaching them new skills (e.g. backwards sailing!).

The training team worked very well this year with everyone willing to be flexible and help where needed, especially in difficult conditions. Thank you to the main beginner's coaches this year - Jon and Tony.

Large numbers of Come and Try's were also taken out by Paul and Oscar and this resulted in several new members joining.

The sessions were well supported by the shore team (Louise, Glenis, Mary, Sarah, Barbara and Mike) and volunteers for safety boat John and Jacub.

A big thank you to any other volunteers that I may have missed (sorry).

Unfortunately we were not able to commit to many Saturday training sessions this year, especially at the end of the season, due to the lack of coaches but those sessions that we did run at the start of the year were well attended and helped to encourage intermediate sailors into racing.

There will be a training meeting very soon to decide on the training calendar for 2020.

Social Media Report - Neil and Rachel McInnes

YSC has had a reasonable presence on Social Media Platforms this year. This has been mainly on Facebook, enquiries on Messenger, a little on Twitter, some on the Website. We had hoped to develop an Instagram presence as well but that didn't happen. We are using Social Media to post regular updates and photos from the Club and keep abreast of what is going on locally, both sailing and local interest and share other posts that members may find interesting.

It was on Facebook that we first found out that a new group had taken over the fishing rights on the Tarn and they have been active and vocal on the platform since.
