## YSC AGM 23rd March 2023

Held at Yeadon Sailing Club and attended by 20 members Apologies for absence ; Glenis Burgess Rachel McInnes

1.

The minutes of the 92nd Annual General Meeting held on the 15th March 2022 were proposed for approval Proposed : Phil Graham Seconded : Jon Wheble Approved unanimously

Trustees Report and Club Officers Reports were discussed. Main points raised :-

Treasurers Report - Tony Langley reported that the Finanical Report was not finalised or approved by the Auditors. This was due to a couple of issues however Louise Harding and Tony Langley were working to finalise the accounts and complete the transfer of the Treasurer's duties and to resolve outstanding membership details.

Key points from the Financial Report ; Club reserves had dropped due to repairs carried out in the last year, donations were down (previous years benefited from COVID support funds that the Club had obtained), memberships were down and expenditure had exceeded income by approximately £4k. It was proposed to raise membership subs by 10%, to be discussed later in the meeting. There was a need to control costs over the next 12 months and hopefully no big building expenditure would be required. Bosun's Report - Paul Bradley reported that the Western end of the jetty (LSAC side) had been condemned and LSAC had questioned the condition of our side (overflow to the slipway), Paul to monitor. AP Gair on behalf of LSAC had complained to the Council about the slippery slipway area.

Paul also went through the work he had been doing to develop new 'fish friendly 'buoys in conjunction with the the fishing club and that he was endeavouring to have a complete set for the beginning of the season.

Annual statement of accounts - Based on the Treasurers report the draft accounts were received and it was proposed that they are accepted as such.
